Vending Accelerator Extension Agreement

Vending Accelerator(the company) and Axis Healthy Vending Systems(the customer) have agreed to extend its originally dated contract of July 14, 2023 for a total period of no more than 60 days/8 weeks ending March 8, 2024. Beginning January 18 2024 and every two weeks(said period) thereafter Vending Accelerator will secure 2 vending locations every two weeks for Axis Healthy Vending. If Vending Accelerator(the company) is unable to secure two locations every two weeks(the period), Vending Accelerator(the company) shall refund \$5,000.00 (five thousand dollars) to Axis Healthy Vending Systems each period until said total amount is refunded in full (please see table below). Axis Healthy Vending Systems is owed in a total of 8(eight) locations in the southeast valley of Phoenix and 8(eight) locations in the Southeast area of Denver, in total locations, 16 (sixteen).

Locations are described and agreed to be one of the following; schools with at minimum enrollment of 300 to 999 students and or YMCA locations with 300 to 999 active members. The specific location will be exclusive with no other vending competitors on site. Refunds will be wired at the end of the period following the day's end to the Chase Bank account provided to Vending Accelerator( see below)

*The parties agree that this agreement can not be included in any bankruptcy proceeding and by execution of signature acknowledge and by their free will and of sound mind that the company and its owner-operator/president, Mr. Ryan O'Keefe have agreed to the exclusions. Should a bankruptcy be imminent the company and or Mr. Ryan O'Keefe agree to waive any legal proceedings and further allow any bankruptcy trustee/judge to allow this claim to be excluded in full until paid and satisfied. Further, any default of part of the company and all legal proceedings, and collections shall be held liable in the State of Arizona and shall be bound by the laws of the State of Arizona.*
